INTRODUCTION

Purpose of This Document

This document provides detailed steps on setting up and accessing your Santa Clara County resources remotely.

Please read this document in its entirety before calling the IS Service Desk for assistance.

Intended Audience

All HHS employees and designated and approved third-parties vendors who are authorized for remote access to HHS applications.

Process Overview

1. Request Remote access (**new remote access users**), existing remote access users will submit a Service Desk request for a confirmation URL
2. Download the RSA SecureID Software Token App to your mobile device
3. Import the token using the confirmation URL on your mobile device that you will receive from the Service Desk
4. Access the remote access site at <https://scvhhsremote.sccgov.org>
5. Update Citrix Receiver (if needed)
6. Enter your Tokencode

To Get Started You Will Need:

1. A current active HHS network account (also known as your Active Directory account).
2. You must have completed the necessary remote access permission forms supplied by IS.
3. A mobile device for your authentication code
4. A supported device to remotely access your HHS resources.
5. A supported internet browser.

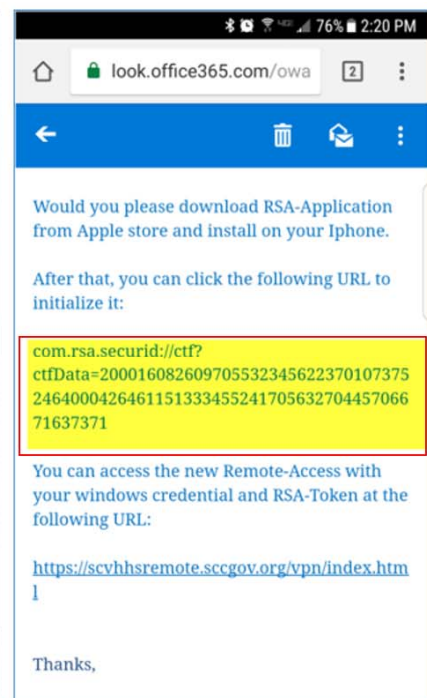
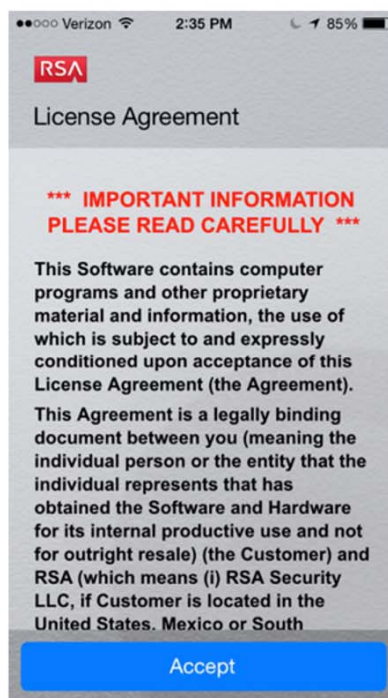
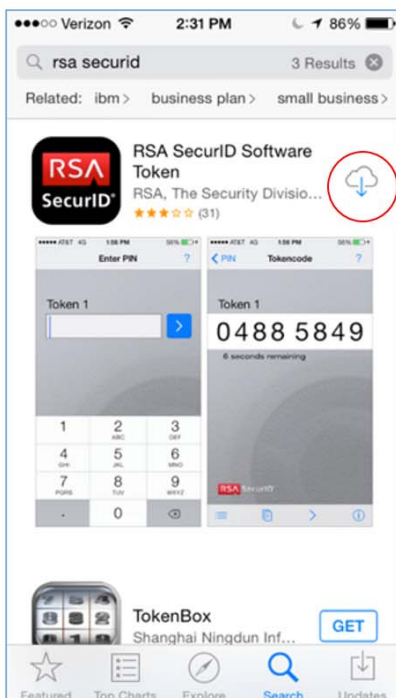
RSA SecureID Authentication

The RSA SecureID Authenticate app generates one-time passwords for additional security when remotely accessing HHS Internal resources. The app needs to be downloaded to a mobile device. To connect a remote session you will enter both your HHS Username and password (Active Directory username and password) along with the generated token from the RSA SecureID app on your mobile device.

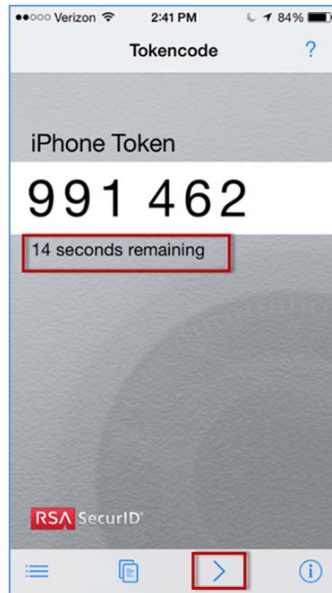
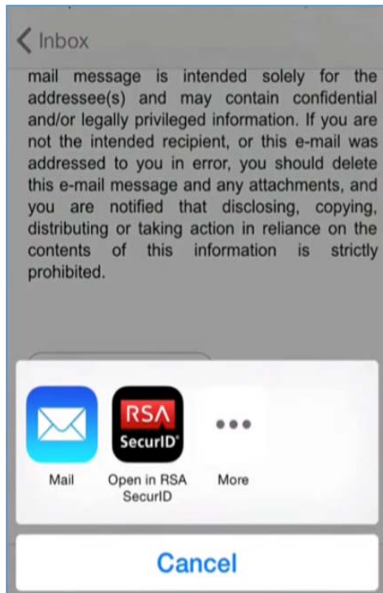
Download RSA SecureID on an Apple device:

In this step you will download the app and then use the URL you receive via email from the Service Desk to initiate the App once you've installed it.

1. Open Apple/iTunes store and search for RSA SecurID in the search field.
2. Select **RSA SecurID Software Token** app
3. Tap on the **download** (Cloud) button to begin installation process
4. Once installed, **open** your SecurID app
5. **Accept** the license agreement and you will be taken to the import window
6. Import the token Using the confirmation URL from Service Desk
7. Open the email from the Service Desk containing your token URL
 - a. If you do not have access to your SCC email account on your mobile device you can forward the email to your personal email account
8. Tap the URL link



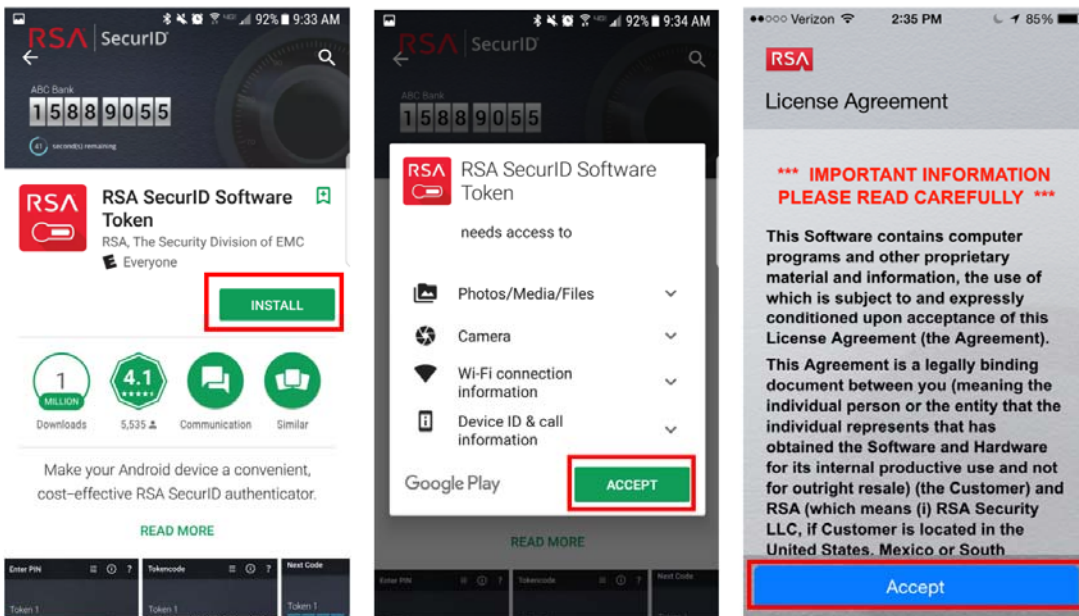
9. If prompted select RSA SecurID from the list of applications to open the link
10. Tap OK to begin using your RSA SecurID to log onto the remote access
11. Note that the token will update every 30 - 60 seconds, you must enter the token in the Remote Access logon window within the time noted
 - a. You can tap Next >to get a new token



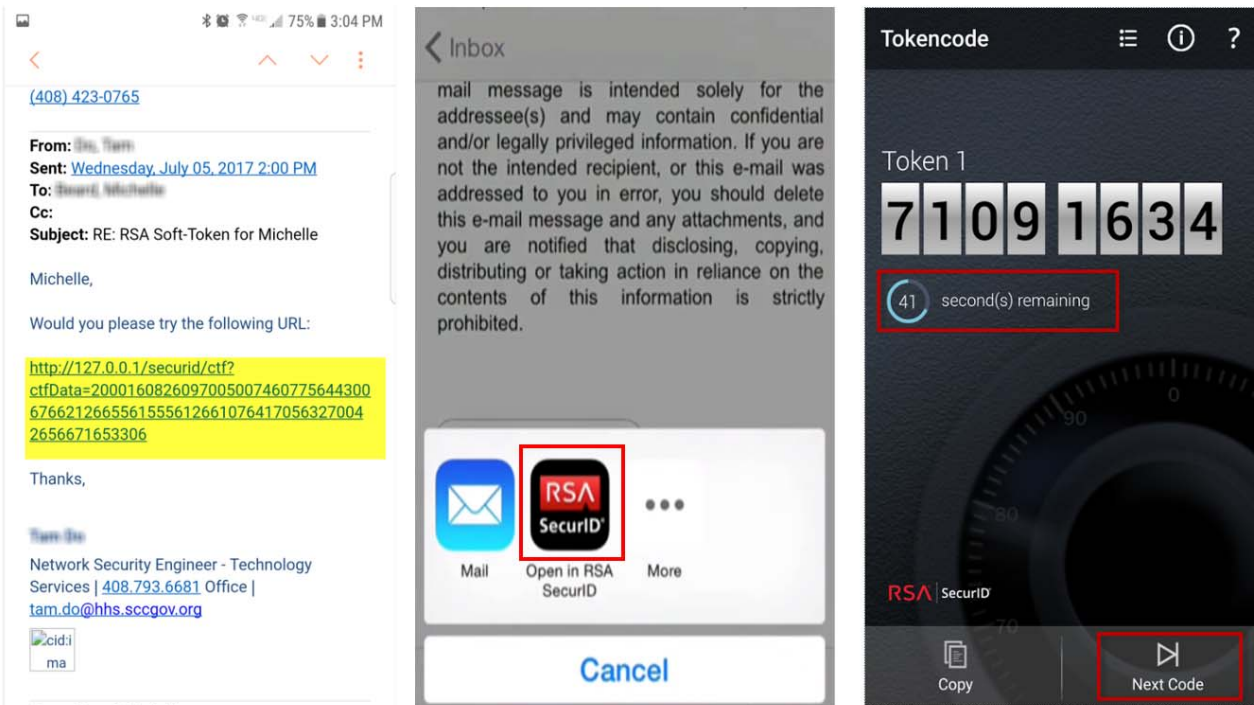
Download RSA SecurID on an Android device:

In this step you will download the app and then use the URL you receive via email from the Service Desk to initiate the App once you've installed it.

1. Open Google Play Store and search for RSA SecurID in the search field. Select RSA SecurID Software Token app
2. Tap on the **Install** button to begin installation process
3. Click **Accept** to allow access
4. **Accept** the license agreement and you will be taken to the import window
5. Once installed, **open** your SecurID app



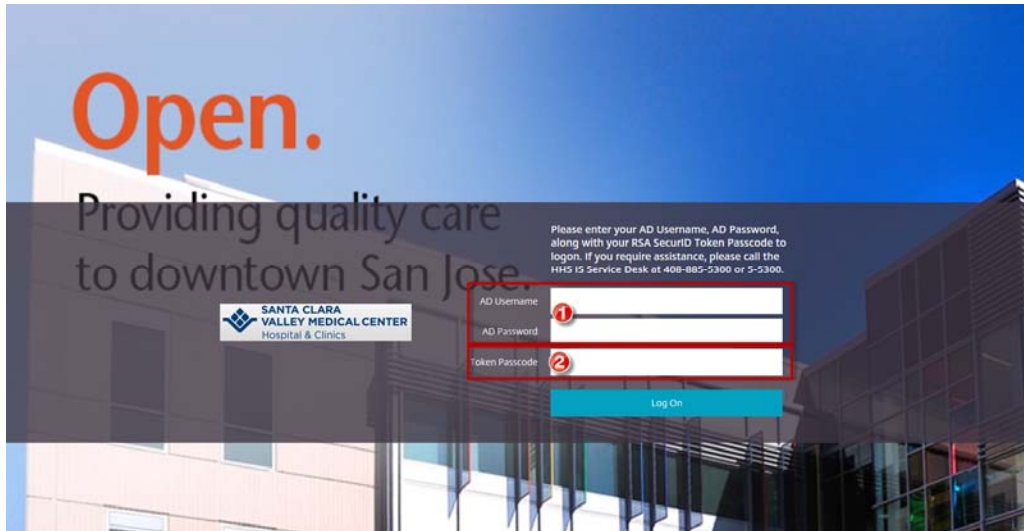
6. Import the token Using the confirmation URL from Service Desk
7. Open the email from the Service Desk containing your token URL
 - a. If you do not have access to your SCC email account on your mobile device you can forward the email to your personal email account
8. Tap the URL link
9. If prompted select RSA SecurID from the list of applications to open the link
10. Tap OK to begin using your RSA SecurID to log onto the remote access
11. Note that the token will update every 30 - 60 seconds, you must enter the token in the Remote Access logon window within the time noted
 - a. You can tap Next >to get a new token



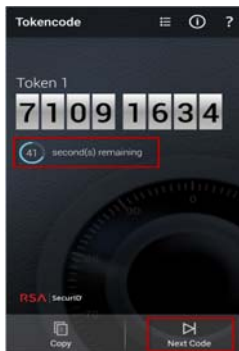
Launch a Remote Session

NOTE: Turn off your pop-up blocker on your web browser before proceeding.

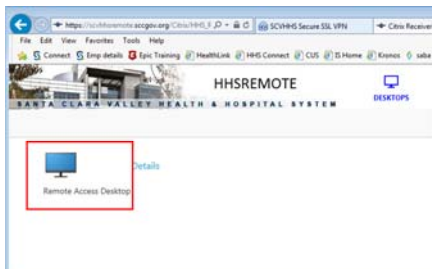
1. Using a supported browser on a supported device navigate to <https://scvhhsremote.sccgov.org>



2. Enter your AD Username and password. These are the same credentials you use to access your workstation
3. Open the RSA Token app on your mobile device
4. Enter the Token passcode
 - a. Note: you must enter the passcode within the time noted, select Next if you need more time



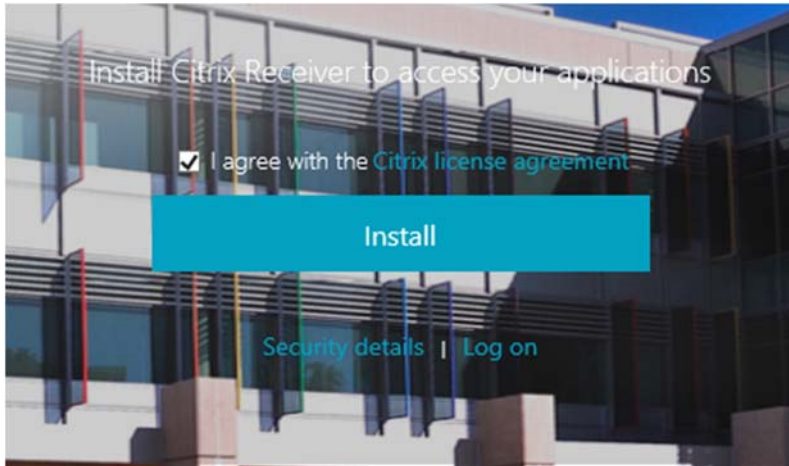
5. Click **Log on**
6. You will be connected to your remote session
 - a. **If you are prompted to install or update your Citrix Receiver, follow the steps in the next section**
7. Click the Remote Access Desktop icon to be connected to your desktop resources



Installing or Updating Citrix Receiver

Note: this step will be skipped if you have the current version of Citrix

1. If you do not have Citrix Receiver, or the most current version installed already, you will be prompted to install it
2. Click to check the box to accept the Citrix agreement then click Install

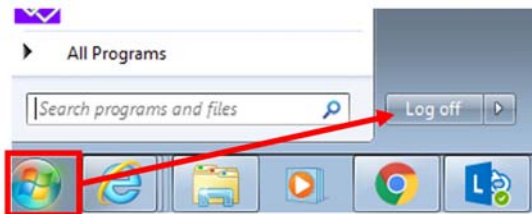


3. Click Start to begin the installation process
4. Once you complete the installation you will be returned to the remote logon screen
5. Enter your AD username, password and RSA Token as described in the previous section

Logging Off

When you are done with your remote session you will need to **log off** of your remote desktop, just as you do with your desktop or laptop. Do not just disconnect/close the window. Logging off helps ensure you will be able to log onto future sessions without any issues.

1. Click the Windows start icon and then select Log off



2. You can then Log off of the remote session or simply close the browser window



Things to Note Once Connected

- You may not cut and paste from your local computer into the remote session, or vice versa. This is a security precaution to protect HHS sensitive information.
- Printing to your local/home computer is disabled. Again, as a security precaution.
- Your remote session will not have access to your local/home disk drives, such as your laptop C: drive. This again, is a security precaution.
- You will see a standard set of icons on the remote session desktop, including ALL personal desktop icons from your HHS work computer. As such, you may see more icons than the picture shown above.
- Only our standard HHS enterprise wide applications are available on the remote session desktop. For example: HealthLink. Departmental and personal workstation installed applications will not be available on the remote desktop session.
- It is important to realize you are not remotely connected to your actual work computer. Rather, what you see on the remote access session desktop is a close approximation of your work computer.

Tips & Hints

- My session keeps disconnecting.
 - If you are wireless, try to get a better signal.
 - Make sure you don't have other applications running on your computer while you are connected to Remote Access.
 - If you have a Mac, make sure you have the Latest receiver for MAC 12.5
- If you "disconnect" for any reason you may reconnect within 5 minutes without losing any of your data or changes.
- If you have the Windows or Mac firewall turned on, please make sure you allow all traffic to/from <https://scvhhsremote.sccgov.org>. If that still won't work, then temporarily shut off your firewall.
- We recommend that you not enable "private browsing" setting in your browser. This will prevent necessary cookies from being installed as part of the first time login process.
